Avalon Woods II Board Meeting Minutes

1. **Call meeting to order & establish quorum:** 4:58pm (Megan calls to order); we have 2 of 3 Board members present, quorum has been established.
2. **Review & approve of previous minutes (May 5, 2026):** Megan motions to approve the minutes as written, Michael seconds, the motion carries.
3. **Manager's Report:**
 - a. Trash – The issue of the dumpster not being fully placed back inside the enclosure is mostly resolved.
 - b. Parking – We reach out as needed for parking violations, such as regular use of visitor spaces or if vehicles are out of compliance with dead tags or inspections.
 - c. Delinquency – There are 2 properties that are significantly delinquent; one has a balance of approximately \$4,500 and had a lien and WID filed in March 2025; the other property has a balance of approximately \$3,000 and the Board has advised us to file a lien. Another property is approaching the \$1,000 threshold for having a lien or WID filed against them; the Board wants us to reach out to the owner and advise them if payment is not remitted, we will proceed with the lien filing process.
 - d. Sales – There has been one sale thus far in 2026, which was 730 Merlins Way, which sold for \$255,000 in March. There are 2 other properties that are listed and set to close soon- 770 Merlins Way and 720 Camelot.
4. **Financial Review (YTD, July 31st):** Through the end of July, we have \$76,741.49 in total operating income and \$30,816.76 in total operating expense. There is nearly \$52,000 in a CD that matures in October.
5. **Old Business:**
 - a. Signs on Dumpsters – WM and Board previously approved for vinyl lettering to be installed on dumpsters (ie- “NO BULK TRASH”, “NO DUMPING”). In the fall when school is back in session, Megan will get the vinyl signs/lettering made.
6. **New Business:** None.
